**The above sanction is subject to the fulfillment of the following conditions:**

1. The school will be inspected by the Inspection Committee constituted by the Board after three months.
2. The school will follow the national syllabus for the Middle/Secondary/Sr. Secondary classes.
3. The school must submit its information through Online Affiliated School Information System (OASIS) as per the Board's Circular No:CBSE/Aff./4/Circular/2016, dated 10.11.2016, within 30 days from the receipt of this grant letter. Link for OASIS is available on Board's website: www.cbse.nic.in.
4. The school will follow syllabi and courses as per scheme of studies prescribed by the Board for Middle/Secondary/Sr.Secondary School Examination and changes made therein from time to time.
5. The school shall appoint only qualified and eligible staff.
6. The school will help the Board in the smooth conduct of the examination by providing the necessary accommodations i.e. Rooms, Halls, etc. available in the school premises and furniture at its disposal for holding its examinations free of charges if required.
7. The school will spare sufficient teachers, for invigilation purpose at the examinations of the Board, as may be required.
8. The school will spare its teachers for evaluation of answer-books for the Board's examinations, if required.
9. The school will provide Laboratories, Library and other facilities as per norms of the Board.
10. The school will abide itself by the conditions of affiliation already prescribed or May be prescribed by the Board from time to time.
11. Service agreement be executed with the staff as per norms accepted by the State Government concerned.
12. Service conditions pay and allowance and other benefits to the employees of the school shall be in no way less than that of corresponding employees working in Government Schools of the State in which the school is located. An undertaking to this effect be sent to C.B.S.E.
13. The school and its records shall be opened for inspection by a Director/official of the Board or an authorized representative of the Board/State Educational Department at any time and the school shall furnish information as may be asked for by the Board/State Government from time to time.

14. The rate of tuition fee and other fees charged should be commensurate with the facilities provided.
15. The admission to the school shall be opened to all without any discrimination on the ground of religion, cast or race, place of birth or any of them.
16. No unrecognized classes shall run within the premises of the school or outside in the same name of school.
17. The School will not sponsor candidates for Board's examination of any other School/Branch, which is not affiliated.
18. The school will create Reserve Fund as per the requirement of the Affiliation Bye Laws/Rules of the Directorate of Education, Delhi in the joint names.
19. It will continue to pay Annual Fee of Rs.5000/- per annum. The schools run by Govt./Govt. Aided are granted regular affiliation and these schools have been advised to remit prescribed annual fee through link provided on Board website www.cbseaff.nic.in.
20. Annual fee has been received upto 31/03/2021.
21. The school is required to contact the concerned Regional Office of CBSE for allotment of school number and password for online Registration of candidates.
22. **Special Conditions to be completed by the School within one month.**
  1. The School is required to appoint special educator as per Rule No. 2.4.11 of Amended Affiliation Bye-Laws of the Board 2018.
  2. The School is required to follow the safety guidelines as issued by the Board vide Circular No. 19/2017 dated 12.09.2017 captioned "Safety of Children in Schools".
  3. The School is required to procure more books subject to minimum of 1500 books in school library and submit the purchase bill as the evidence for the same.
  4. The School is required to appoint 05 PGTS for Sr. Secondary Classes.
  5. The school is required to appoint 08 more TGTS, Librarian & PTI.
  6. The School is required to submit Latest Fire Safety Certificate issued by the Fire Department.
  7. The School is required to submit Latest Safe drinking Water & sanitary condition Certificate issued by the State/Govt.
  8. The School is required to submit Latest Building Safety Certificate issued by the State/Govt.
  9. The School is required to submit Establishment letter.
  10. The School is required to submit Govt. Certificate Appendix-II, as per New Affiliation Bye-Laws 2018.
  11. The School is required to mention whether the school is running in two shifts.
  12. The School is required to standard staff of the teachers training.
